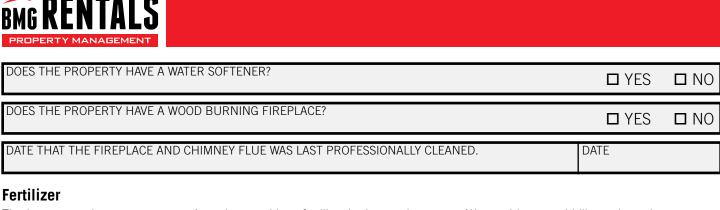

The best way to keep your property's curb appeal is to fertilize the lawn twice a year. We set this up and bill you through your owner's statement in spring and fall.

HVAC Filter

Please be sure to have a clean air filter in the furnace at move out. We also check and replace filters during inspections.

Smoke Alarms

At least one smoke alarm is to be placed in each bedroom or in the room used for sleeping in the case of an efficiency unit. In addition, if multiple bedrooms are served by the same hallway, there must be a smoke alarm in the hallway in the immediate vicinity of the bedrooms; and if the unit has multiple levels, there must be a smoke alarm on each level.

Carpet Cleaning

We require Tenants to have the carpets professionally cleaned at the time of move-out. Therefore, the carpets must be professionally cleaned before the tenants take possession of the property. Please provide BMG with a receipt for cleaning so we can hold tenants to the same standard. Rented carpet cleaning machines do not count as professional carpet cleaning.

Cleaning

Our experience has been that after the work and stress of moving out, many owners are too tired to clean the property thoroughly. We recommend considering a professional cleaning company. You are certainly free to choose any company, or we will be happy to recommend a company that we use. BMG will coordinate professional cleaning at the owner's expense if the property is not move-in ready. Once the property is brought up to this standard we are able to hold the tenants responsible for future cleaning.
